Layaway Agreement

Please fax or mail this completed agreement to us. Please print clearly.

For your convenience, we offer 30, 60 and 90-day layaway plans. Choose the plan that is most convenient for you. There are no service charges for our layaway plan. Please follow the ordering steps below. Please contact us with any questions or concerns you have.

TERMS AND CONDITIONS

- Orders of \$50.00 or more (not including shipping) qualify for our layaway plan.
- A 25% initial deposit is required for all layaway purchases.
- Payment methods accepted for layaway purchases: Credit card (Visa, Master Card, Discover, or American Express), check, money order, or Paypal.
- Payments must be received by the due date and in accordance to the payment plan, chosen below.
- Monthly payments will be due on the same day of the month that order was submitted to us, until paid in full. (e.g.: order submitted on July 1st; payments will be due each month on the 1st).
- If you have trouble making a payment please contact us immediately (before your payment is due). We will work with you.
- In the event of default or cancellation, Layaway payments will be issued as store credit only in the form of a Gift Certificate Code. Half of your initial deposit will not be refunded or included in the Gift Certificate amount. No cash refunds.
- Orders will be cancelled 30 days after a payment is missed and we will issue a store credit for the amount paid (half of your initial deposit will not be refunded or included in the store credit) in the form of a Gift Certificate Code that can be used for any purchase on our site.
- Once we have received your final payment, your order will be shipped within 2 business days unless your final payment is made by check, in which case your order will ship when the check clears the bank (typically about 10 business days).

ORDERING STEPS

1. Layaway orders may be made through our website or by fax.
2. If placing an order via our website, place the items you would like to order into your shopping cart. Then proceed with checkout. Enter coupon code: LAYAWAY25 during checkout. Your initial deposit will be 25% of your total order (not including shipping). The remaining amount due will be divided into equal payments based on the payment plan chosen below.
3. If placing an order via fax, complete this agreement and print shopping cart page from FreeBears.com from step 2 above. Then fax both forms to us.
